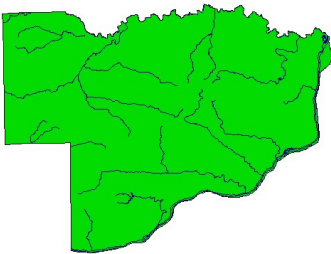


Our Mission is to improve the stewardship of Scott County watersheds through education, technical guidance, and volunteer opportunities.

In 1990, 1993 & 1995, severe flooding occurred on Scott County urban streams. This flooding was a result of the conventional methods being used to deal with storm water. These events and concerns with water quality in Scott County streams led to the formation of the Partners of Scott County Watersheds, an alliance committed to developing and implementing ways all citizens can be better stewards of our watersheds.

We had the delightful opportunity to onboard a new Coordinator, Kelsi, early in the year and she hit the ground running planning our events and managing grant funds. We were also honored to have Carter join our Board as Treasurer.

Through yet another year of the COVID-19 pandemic, Partners was honored to have so many volunteers from our communities participate in our Snapshot water quality monitoring events and

reach record numbers of students and adults through our virtual educational forums, workshops and other outreach efforts. The recently adopted Crow Creek Wildlife Management Area also received some outstanding volunteer efforts, with a tree sinking day for fish habitat, an Earth Day cleanup, and a fall brush removal day. We were also able to participate with 11 communities throughout the county with August Water Quality Month proclamations and organized trash cleanups.

We will continue to improve and expand our volunteer and education events in 2022. We will also continue our research partnerships with St. Ambrose University and Augustana College to collect watershed data and E. coli studies. We couldn't continue this work without all of you! There is a lot to be done and we are proud to invest our time and energy in this work. We thank all of you for your continued support and look forward to working with you to improve all of Scott County's watersheds.

2021 SUCCESS STORIES

While navigating a new normal and bringing on a new coordinator, PSCW continued to provide education, technical guidance, and volunteer opportunities to Scott County. Here are some of this year's highlights!



- Reached nearly 2000 people through education with forums, outreach, and workshops.
- Engaged 280 eighth grade students in water quality monitoring and careers in STEM at the Bettendorf Middle School field day.
- Had 245 volunteers at community cleanups and Snapshots.
- Removed almost 90 bags of trash from waterways and water fronts!
- Worked with several local organizations including Spring Forward and Living Lands and Waters to host a "Floating Classroom" for 25 sixth grade students!
- Provided 8 communities with pet waste stations to reduce fecal bacteria and nitrogen pollution.
- Spread awareness of water quality and PSCW with Water Quality Stewardship Month proclamations in 10 Scott County communities.
- Received over \$16,000 through grants to fund water quality improvement projects!
- Conducted 5 site visits to private land owners to provide assistance in water quality improvements.
- Participated in the Mississippi River Plastic Pollution Initiative to collect data and remove trash from the community.
- Partnered with St. Ambrose to monitor water quality at Robin Creek bio filters.

2021 FORUMS

As much as we missed seeing everyone in person, hosting virtually allowed us to reach a new audience and record these presentations for later viewing and sharing. 2021 SNAPSHOTS

A Snapshot is a day of water quality monitoring, which altogether, provides a 'snapshot' of the water quality conditions around Scott County.

This year was yet another great year of testing, with nearly 100 Snapshot volunteers throughout our spring, summer, and fall events! For all three Snapshots, chemical water quality data was collected at 62 sites, providing representative data for each of the major watersheds in the county. Additionally, 10 sites were surveyed for benthic macroinvertebrate populations during the summer Snapshot to determine the index of biological integrity and indicative water quality status. Lab analyses were also conducted for nitrate, nitrite, orthophosphate, herbicide, pesticide, and microbial source tracking for fecal matter throughout all the events.

This year, with the help of Eastern Iowa Community Colleges and the Scott County GIS team, PSCW started collected data using a mobile app and tablets. This has greatly increased our ability to collect and analyze Snapshot data— see it for yourself at www.scottcountyiowa.maps.arcgis.com!

Starting in the summer, we were able to utilize another new piece of equipment: Hach Pocket Pro meters! Pictured on the right, these small meters provide detailed readings on water temperature, pH, total dissolved solids, salinity, and conductivity. The Pocket Pro meters have increased our range of tests and improved data accuracy — *thank you Nahant Marsh for lending these meters to PSCW!*



Finally, we received a grant from the Regional Development Authority, and with these funds were able to purchase a Hach Colorimeter. This meter provides much more accurate readings for orthophosphate levels than our previous method of in-field color comparators.



Snapshot Findings

Data from this year's Snapshots indicate that there are concerns for nitrate, phosphate, and chloride level trends in both rural and urban streams, along with concerns for fecal bacteria. Transparency has somewhat undesirable trends, with a few streams of greater concern. pH is good, but seems to be trending slightly higher, and dissolved oxygen is generally in range with a few streams of concern.

Overall, most of our streams originate within the borders of Scott County, so it is up to us to address these concerns and improve the health of our watersheds!

WHAT'S NEXT?

2021 has been a busy and exciting year for PSCW, and we plan to continue that momentum into 2022. Here are some of next year's plans!

- Work with Davenport and Bettendorf to create small boat and fishing access points along Duck Creek.
- Install stream and watershed education signage along the Duck Creek Parkway, including three geological interpretive signs in Devil's Glen park.
- Coordinate the first annual member appreciation float and picnic.
- Continue to partner with St. Ambrose University and Augustana College for research projects.
- Provide outreach and educational programming to K-12 students.
- Encourage and assist landowners and citizens to help address water quality concerns.
- Create a digital platform for macroinvertebrate data collection.
- Provide Scott County communities with additional pet waste stations.
- Continue habitat restoration and improvement at Crow Creek WMA.

FORUMS

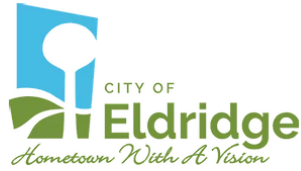
Listen to local experts share about water quality, improvement projects, and conservation news from 12-1pm every third Tuesday of the month, **February through November.**
